3. No food or beverage shall be consumed at SSCC facilities unless purchased from the Club or approved in advance by the Club. All alcohol must be purchased from Sulphur Springs Country Club per TABC rules.
4. Failure to abide by these restrictions will result in disciplinary actions, up to and including monetary fine.
5. All SSCC canned beer will be wrapped with a Proof of Purchase. Any member or guest caught with outside alcohol will be subject to a monetary fine.

**PAST DUE ACCOUNTS:**

- At the bottom of your monthly statement, you will find the following categories:  
- Current                      - 30 Days                      - 60 Days
- All members' accounts are to be paid in full by the due date provided on the monthly statement.
- Any accounts that are **30 days past due** will be charged a late fee of \$75 (minimum) **and/or** up to 10% of the balance due from the date of the delinquency until paid in full.
- When any account becomes **60 days past due**, your membership will be suspended, and your account will be turned over to the General Manager. Your membership will not return to good standing until the outstanding balance is paid in full. During the suspension period, you will have NO Club privileges and will not be able to make any charges to your membership. Your account will continue to accrue interest charges as stated above.
- Any account that is **90 days past due** will cause your membership to be cancelled, and the Club will seek legal recourse against you for all monies due and all costs associated with the collection thereof. In the event you default on your account, you have acknowledged and agreed to be responsible for all 3<sup>rd</sup>-party collection fees, legal fees, and court costs when you signed and submitted your application.
- You are to maintain a current credit card account on file with the Club. Should your account ever become delinquent, the Club shall have the right to bill such past-due amount to the credit card on file (NO EXCEPTIONS).
- If your account becomes delinquent, SSCC will notify you by written statement or e-mail notification, and it will be your responsibility to contact the Club.

## WAIVER, RELEASE AND INDEMNITY AGREEMENT

To: SULPHUR SPRINGS COUNTRY CLUB, its employees, directors, insurers, agents, successors, and assigns.

In consideration of being permitted to participate in and use the amenities of Sulphur Springs Country Club and/or as a condition of my membership, I \_\_\_\_\_ (hereinafter the "Member") hereby agree as follows:

### PERSONAL PROPERTY

- 1.) Sulphur Springs Country Club, ownership and employees are not responsible for the loss or theft of, or damage to, personal property on the Club's premises, whether held in storage or not. This includes but is not limited to golf clubs, golf bags, golf accessories, money, or other property. The Member will take all precautions to avoid loss or theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold Sulphur Springs Country Club, owner and employees harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of the Club.

Further, as a condition of bringing a guest onto the premises of the Club, the Member agrees to assume all risk of loss or damage to personal property belonging to the guest. The Member agrees to indemnify Sulphur Springs Country Club, owners and employees for any liability, costs or expenses imposed by law upon Sulphur Springs Country Club, owner and employees for any and all such losses.

### GOLF CART RENTALS

- 2.) The Member agrees to assume all risk of loss or damage to motorized golf carts rented or borrowed from Sulphur Springs Country Club, owner and employees as well as the risk of injury to the Member or other persons and damage to other property arising from the use of the golf cart. The Member will take all precautions to avoid loss or damage to the golf carts, damage to other property and injury to persons including to the Member arising out of the use of golf carts. In the event of any loss, damage or injury, the Member agrees to hold Sulphur Springs Country Club, owner and employees harmless from and against any and all claims, costs, expenses and demands in respect of such loss, damage or injury, howsoever caused.

The Member agrees to indemnify and reimburse Sulphur Springs Country Club, owners and employees for any liability, costs or expenses imposed by law upon Sulphur Springs Country Club, owner and employees for any and all such losses.

### GENERAL WAIVER

- 3.) The Member acknowledges that there are risks inherent in participating in the game of golf and golf (sports) simulators. The Member agrees to release the Sulphur Springs Country Club, owner and employees from any liability from personal injury, property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage, directly or indirectly resulting from the Member's activities or participation in activities at the Club. The Member further waives, as against the Sulphur Springs Country Club, owner and employees, all claims, recourse and rights of action that the Member may have against Sulphur Springs Country Club, owners and employees as a result of such personal injury, property damage or loss.
- 4.) The Member agrees that this Waiver, Release and Indemnity Agreement shall not be affected by any negligence, gross negligence, breach of contract, or any other conduct on the part of Sulphur Springs Country Club, owners and employees.
- 5.) The Member acknowledges that he or she has read this Waiver, Release and Indemnity Agreement and understands and accepts the contents hereof.



- 6.) In the event that any provision herein contained is deemed to be unenforceable and/or invalid, the provision shall be severable from the whole of the document and shall not affect the validity and enforceability of the other provisions and the document as a whole.

**GYM RELEASE FORM MUST BE COMPLETED BY ALL INDIVIDUALS USING THE GYM**

**RELEASE, WAIVER AND INDEMNIFICATION FOR THE USE OF  
FITNESS CENTER AT SULPHUR SPRINGS COUNTRY CLUB**

The undersigned, \_\_\_\_\_ (referred to herein as the "User") has requested the use of fitness equipment ("Fitness Equipment") owned or otherwise provided by Sulphur Springs Country Club ("Owner") or any successor thereof for use in the Fitness Facility ("Fitness Facility") at the property commonly known as Sulphur Springs Country Club (the "Property").

For and in consideration of the use of the Fitness Equipment and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, User agrees as follows:

1. To the fullest extent not expressly prohibited by law, User releases Owner and Managing Agent and any and all mortgagees of the Property, and their respective successors, assigns, agents, beneficiaries, partners, members, officers, servants and employees, beneficiaries, partners (direct or indirect), members, shareholders, officers, and employees (collectively referred to herein as the "Released Party") from and waives all claims for injury to or death, except to the extent injury to or death of any person is caused by the negligence or willful misconduct of the Released Party resulting directly or indirectly from User's use of the Fitness Equipment. All personal property belonging to User in the Fitness Facility shall be at the risk of the User, and Released Party shall not be liable for damage thereto or theft or misappropriation thereof.
2. To the fullest extent not expressly prohibited by law, User shall hold harmless and indemnify Owner and the Property against all third-party claims and liabilities, including attorneys' fees and costs, for injury to or death of any person (other than to the extent injury to or death of any person is caused by the negligence or willful misconduct of the indemnified party) or damage to or misappropriation or loss of property occurring in or about the Fitness Facility resulting directly or indirectly from User's use of the Equipment or from any accident in or about the Fitness Facility or any part thereof or from any act or omission of User related to the use of the Fitness Facility. In the event any action or proceeding is brought against Owner, by reason of such claims, then, upon notice from Owner, User covenants to defend such action or proceeding by counsel satisfactory to the User.
3. If any damage to the Fitness Facility or Fitness Equipment results from any act or neglect of User, then User shall upon demand by Owner pay to Owner the reasonable cost of such repair to the Equipment or Fitness Facility as it relates solely to User's act or neglect.

The foregoing release, waiver and indemnity shall be in addition to and shall not be limited by any other waiver, release to claim of indemnity contained in any contract or other agreement between User and Owner.
