The Corporation (Business) is responsible for each designee's monthly membership fee, and the designee is responsible for all other expenses. Cart privileges are available at an additional cost and can be added to the Corporate Monthly Fee.

- Monthly statements are generated the 10th of the month with payment due on the last day of the month (for example, statements issued March 10th are due March 31st)

- <u>I agree that any resignation submitted by me shall be in writing to the Club (30) days in advance</u>. I understand that my resignation shall not relieve me of any obligations or indebtedness of mine to the Club and that I remain responsible for all charges, including but not limited to unpaid initiation fees. Resignation shall be sent to SSCC's business office thirty (30) days in advance. Upon resigning, former member must wait one (1) year before eligible for rejoining or pay back dues from date of resignation.
- Any upgrade or downgrade of membership requires a one (1) year commitment to the new designated level of membership that has been selected.
- I hereby acknowledge that all of the statements set forth in this application are true and correct, and that I have withheld no information of a material nature, which would negatively affect my membership application.

PAST DUE ACCOUNTS:

• All members' accounts are to be paid in full by the due date provided on the monthly statement. Any accounts that are 60 days past due can be charged a \$10 late fee. The late fee, if charged, will be assessed monthly until the entire balance is paid in full. At such time as any account becomes 60 days past due, and SSCC has not heard from you and/or arrangements to pay your balance have not been made, your membership will be suspended Sulphur Springs Country Club ©2021



and your account will be turned over to the Board of Directors. Your membership will not return to good standing until the outstanding balance is paid in full. During the suspension period, you may have no club privileges and may make no charges to your account. Any account that is 120 days past due will cause your membership to be cancelled, and the Club will seek **legal recourse** against you for all monies due and all costs associated with the collection thereof. In the event I default on my account, I acknowledge and agree I will also be responsible for all 3rd-party collection fees, legal fees, and court costs.

- I also agree to maintain a current credit card account on file with the Club should my account ever become delinquent, and I agree the Club shall have the right to bill such past-due amount to my credit card.
- If your account becomes delinquent, SSCC will notify you by written statement or e-mail notification, and it will be your responsibility to make an arrangement for payments with the Club.

WAIVER RELEASE AND INDEMNITY AGREEMENT

To: <u>SULPHUR SPRINGS COUNTRY CLUB</u> ,	its employees, directors, insurers, agents, successors, and

In consideration of being permitted to participate in and us	se the amenities of Sulphur Springs Country Club and/or as a
condition of my membership, I	(hereinafter the "Member") hereby
agree as follows:	

PERSONAL PROPERTY

1.) Sulphur Springs Country Club, ownership and employees are not responsible for the loss or theft of, or damage to, personal property on the Club's premises, whether held in storage or not. This includes but is not limited to golf clubs, golf bags, golf accessories, money, or other property. The Member will take all precautions to avoid loss or theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold Sulphur Springs Country Club, owners and employees harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of the Club.

as a condition of bringing a guest onto the premises of the Club, the Member agrees to assume all risk of loss or damage to personal property belonging to the guest. The Member agrees to indemnify Sulphur Springs Country Club, owners and employees for any liability, costs or expenses imposed by law upon Sulphur Springs Country Club, owners and employees for any and all such losses.

GOLF CART RENTALS

2.) the Member agrees to assume all risk of loss or damage to motorized golf carts rented or borrowed from Sulphur Springs Country Club, owners and employees as well as the risk of injury to the Member or other persons and damage to other property arising from the use of the golf cart. The Member will take all precautions to avoid loss or damage to the golf carts, damage to other property and injury to persons including to the Member arising out of the use of golf carts. In the event of any loss, damage or injury, the Member agrees to hold Sulphur Springs Country Club, owners and employees harmless from and against any and all claims, costs, expenses and demands in respect of such loss, damage or injury, howsoever caused.

the Member agrees to indemnify and reimburse Sulphur Springs Country Club, owners and employees for any liability, costs or expenses imposed by law upon Sulphur Springs Country Club, owners and employees for any and all such losses.

FITNESS FACILITY

3.) the Member agrees to acknowledge and user agrees as follows: To the fullest extent not expressly prohibited by law, User releases Owner and Managing Agent and any and all mortgages of the Property, and their respective successors, assigns, agents, beneficiaries, partners, members, officers, servants and employees, beneficiaries, partners (direct or indirect), members, shareholders, officers, and employees (collectively referred to herein as the "Released Party") from and waives all claims for injury to or death, except to the extent injury to or death of any person is caused by the negligence or willful misconduct of the Released Party shall not be liable for damage thereto or theft or misappropriation thereof.

To the fullest extent not expressly prohibited by law, User shall hold harmless and indemnify Owner and the Property against all third claims and liabilities, including attorneys' fees and costs, for injury to or death of any person (other than to the extent injury to or death of any person is caused by the negligence or willful misconduct of the indemnified party) or damage to or misappropriation of loss of property occurring in or about the Fitness Facility resulting directly or indirectly from User's use of the Equipment or from any accident in or about the Fitness Facility or any part thereof or from any act or omission of User related to the



use of the Fitness Facility. In the event any action or proceeding is brought against Owner, by reason of such claims, then, upon notice from Owner, User covenants to defend such action or proceeding by counsel satisfactory to the User.

If any damage to the Fitness Facility or Fitness Equipment results from any act or neglect of User, the User shall upon demand by Owner pay to Owner the reasonable cost of such repair to the Equipment or Fitness Facility as it relates solely to User's act or neglect..

GENERAL WAIVER

- 4.) the Member acknowledges that there are risks inherent in participating in the game of golf. The Member agrees to release the Sulphur Springs Country Club, owners and employees from any liability from personal injury, property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage, directly or indirectly resulting from the Member's activities or participation in events at the Club. The Member further waives, as against the Sulphur Springs Country Club, owners and employees, all claims, recourses and rights of action that the Member may have against Sulphur Springs Country Club, owners and employees as a result of such personal injury, property damage or loss.
- 5.) the Member agrees that this waiver, release and indemnity agreement shall not be affected by any negligence, gross negligence, breach of contract or any other conduct on the part of Sulphur Springs Country Club, owners and employees.
- 6.) the Member acknowledges that he or she has read this waiver, release and indemnity agreement and understands and accepts the contents hereof.
- 7.) in the event that any provision herein contained is deemed to be unenforceable and/or invalid, the provision shall be severable from the whole of the document and shall not affect the validity and enforceability of the other provisions and the document as a whole.
- 8.) I also allow the Sulphur Springs Country Club to publish my name/picture (Personal Information Protection and Electronic Documents Act) on the website, bulletin board, newsletters, or other publications.
